### **OFFICIAL RULES**

### NO PURCHASE IS NECESSARY TO ENTER OR WIN

**ELIGIBILITY:** The 2021 *Threads* Digital Ambassadors' Runway Sewn Your Way Challenge (the "Contest") is open only to legal residents of the fifty (50) United States, and the District of Columbia, who are at least eighteen (18) years old at the time of entry, and who are not employees, directors, officers, and contractors (including immediate family members and members of the same household) of The Taunton Press, Inc., publisher of *Threads®* magazine ("Administrator"), Janome America, Beautiful Textiles, or Wild Ginger Software, (the "Sponsors"), or their respective affiliated companies, distributors, or vendors, or other entities associated with this Contest (the "Entrant" or "Entrants").

**ENTRY PERIOD:** Completed entry forms with photographs for the Contest will be accepted only during the period beginning at 12:01 a.m. Eastern Time on September 3, 2021 and ending at 11:59 p.m. Eastern Time on November 3, 2021 (the "Entry Period"). To be valid, completed entry forms and photographs must be received during the Entry Period. Administrator's computer is the official time keeping device for the Contest.

Entries are subject to verification and will be declared invalid if they are illegible, mechanically reproduced, mutilated, forged, falsified, altered, or tampered with in any way. Entrants must abide by these Official Rules and Regulations (the "Official Rules") and by entering this Contest you agree to adhere to the terms, policies and guidelines described in these Official Rules. In the event of a dispute as to any entry, the authorized account holder of the e-mail address associated with the account used to enter will be deemed to be the Entrant.

You must submit 3, and up to 6, photographs of your custom-made garments during the Entry Period.

**JUDGING CRITERIA:** The garment or ensemble submitted in the photographs must be sewn by you and inspired by a designer(s) past or present. Submissions will be judged by two groups: the *Threads* Audience and the *Threads* Digital Ambassadors.

- The *Threads* Audience winner will be the semi-finalist entry with the most audience votes.
- The Threads Digital Ambassadors' winner will be judged on the following:
  - 1. Interpretation of the designer inspiration garment(s)
  - 2. Quality of sewing
  - 3. Appropriate materials for the project

**JUDGING:** After the close of the Entry Period on November 3, 2021, *Threads* Editors will review all photographs and answers submitted on time and choose up to six (6) semi-finalists from among all the valid submissions received. The photographs from the semi-finalists will be posted online for the *Threads'* Audience viewing and voting.

**NO LATER THAN** November 28, 2021, those in the *Threads* Audience are asked to log onto ThreadsMagazine.com/2021DigitalAmbassadorsChallenge/Vote and vote for your one (1) favorite outfit from among the semi-finalists. Each person logging on to vote may vote only one (1) time. You do not have to have submitted an entry to be able to vote.

#### WINNERS' SELECTIONS:

 WINNER ONE: The Threads Audience votes will be tabulated, and on December 3, 2021 the semi-finalist whose submission received the most votes will be announced as the potential winner. This potential winner will be notified by email using the same email address provided at time of the entry. Odds of winning will depend upon the total number of eligible entries received. WINNER TWO: On December 3, 2021, one (1) potential winner will be announced by the *Threads* Digital
Ambassadors from among all the valid submissions received. This potential winner will be notified by email using
